- **Clinical Trials:** On May 23, 2020, Canada's Minister of Health issued an [Interim Order](#) with regard to clinical trials for medical devices and drugs related to COVID-19. In an effort to ease the burden of companies during this pandemic, the Canadian Intellectual Property Office (“**CIPO**”) and the United States Patent and Trademark Office (“**USPTO**”) have the following updates:

- **CIPO:** Deadlines falling within the period of March 16, 2020 and July 3, 2020 are now extended to [July 6, 2020](#). CIPO may continue to extend the deadlines if it remains in the public interest to do so.
